Job Description: E3R is seeking candidates to fill an Information Security Specialist III opening. The position is described below.

Position Summary: The Information Security Specialist III is a critical role responsible for supporting all aspects of a Program Information Assurance (IA) process. This includes ensuring compliance with Cyber Security, Engineering, Test & Evaluation (T&E), and Security Control Assessor (SCA) functions within a Certification & Accreditation (C&A) or Assessment & Authorization (A&A) framework. The specialist will leverage their expertise in the Risk Management Framework (RMF) process, with prior experience in the Defense Information Assurance & Certification Accreditation Process (DIACAP) being highly desirable. The role requires a hands-on approach to evaluating security solutions, maintaining operational security, and preparing documentation to support Authority to Operate (ATO) requirements.

Position Duties:

- **Support IA Processes:** Assist in the execution of Information Assurance (IA) processes, including the preparation and maintenance of security artifacts and traceability documents.
- **Risk Management Framework (RMF):** Apply knowledge of RMF to support compliance and authorization processes, ensuring the security of information systems.
- **Security Policies & Guidance:** Familiarize and adhere to relevant security policies and guidance documents to maintain the security posture of systems handling up to classified information.
- **Security Solutions Evaluation:** Evaluate and recommend security solutions to ensure they meet the necessary security requirements.
- **Operational Security Maintenance:** Supervise and maintain the operational security posture for various information systems, ensuring ongoing compliance with security policies.
- **Development of Security Policy:** Contribute to or develop system security policies, ensuring compliance with change management and configuration control processes.
- **Coordination of IT Security Programs:** Plan and coordinate IT security programs and policies in alignment with command leadership's mission and goals.

Minimum Qualifications:

- College Degree in a technical or managerial related discipline.
- 5+* years of practical experience in cybersecurity, engineering, Security Test and Evaluation (T&E), or Assessment and Authorization (A&A) (formerly C&A) is required.

- Experience with Information Assurance tools such as DISA Enterprise Mission Assurance Support Service (eMASS), Assured Compliance Assessment Solution (ACAS) is preferred.
