This role integrates operational planning, capability gap analysis, and force sourcing expertise to ensure Requests for Information (RFI) and Requests for Forces (RFF) are analytically grounded, operationally justified, and aligned with Fleet, Joint, and Coalition warfighting requirements.

Functional Description:

Long-Range Operational Planning & Analysis

- Provide analysis and reporting supporting C3F and subordinate unit missions, capabilities, and employment strategies
- Analyze CONOPS, OPLANS, and contingency plans to identify warfighting capability gaps, risks, and vulnerabilities
- Develop recommendations to mitigate force structure and information shortfalls
- Deliver findings through detailed briefs and formal reports

RFI / RFF Validation & Staff Integration

- Disseminate RFFs/RFIs across B2C2WGs to generate coordinated staff recommendations
- Validate operational demand for units, personnel, and information based on projected operational environments
- Consolidate analysis into written products supporting force structure, organizational, and logistics planning decisions
- Enhance survivability, lethality, and operational effectiveness of naval forces

Fleet Capability Gap Assessment

- Conduct operational analysis to identify gaps in command and control, lift capacity, equipment, training, ordnance, and intelligence
- Assess and recommend improvements to force integration across surface, subsurface, air, special operations, and information warfare communities
- Incorporate operational experience, after-action reports (AARs), and lessons learned into capability assessments

Vulnerability & Warfighting Effectiveness Analysis

- Build and refine vulnerability and capability gap assessments accounting for evolving adversary capabilities and increased weapons lethality
- Develop recommendations for Navy, Joint, and Coalition platform and warfighting CONOPS
